CONDITIONS OF PARTICIPATION

1. Place:

Central Hall of the Hamburger Börse - Hamburg Stock Exchange - Adolphsplatz 1

2. Time:

The event will take place from 13 – 15 November 2009.

The booths will be set up on 12 November between 3 pm and 7 pm and on 13 November between 9 am and 2 pm.

Opening hours:

Friday	13th November	3 pm to 8 pm
Saturday	14th November	11 am to 6 pm
Sunday	15th November	11 am to 5 pm.

Colleagues who are not registered for participation in the fair may help setting up only with special permission by the organizer.

The booths will be dismantled on 15 November 2008 between 5 pm and 7 pm.

3. Goods offers and object of the fair:

The goods on offer include the entire area of the general antiquarian book trade such as books, handwritten items, autographs, original graphics items including drawings done by hand and aquarelle. In the case of books printed after 1945 only first editions that are no longer available and bibliophile editions are admissible. Only goods of high quality in good condition may be offered.

4. Sale / Trade:

The sale of exhibits is by the tenant of the booth in his own name and his account.

Each exhibitor guarantees the reliability of the details of declaration of his goods. In the case of justified complaint within 4 weeks, the exhibitor is bound to accept items back. The prices of the exhibits are to be clearly and visibly displayed in Euro inclusive of value added tax.

Goods that are acquired from other exhibitors at the fair may not again be offered for sale during the current fair.

Every item sold must be wrapped by the exhibitor and the package sealed with the fair seal. The wrapping is to be supplied by the exhibitor and the seals are supplied by the organizer.

Transactions prior to the opening of the fair are permitted only to proprietors or managers of companies registered for participation in the fair.

5. Fair catalogue:

Every exhibitor is entered in the fair catalogue with an attractive selection of his range of items. Closing date for submission of the manuscripts is 15. August 2009. The times set by the organizer for the submission of the manuscript and the proofs are binding. No refund of costs will be made for non-entry in the catalogue resulting from late submission. The exclusive exhibition offers advertised in the catalogue – which must be clearly marked as such – must be kept for sale until the exhibition starts. Other books in the catalogue can be sold as soon as the catalogue is published. Reservations can only be taken after the second day of the exhibition. Catalogue items may only be sold to other exhibitors after the fair has been open for at least one hour. No claims can for compensation be enforced with regard to errors, incomplete entries or omissions. The exhibitor is responsible for the contents of entries and any damage incurred by the publication thereof.

6. Address file:

Each new exhibitor will make available fifty of his current collector's addresses. The organizer gives an undertaking that the addresses made available will only be used for the mailing of the fair catalogues. Closing date for submission is 31. Juli 2009.

7. Costs:

The participation fee for the booths covers fair construction, advertising, catalogue production and mailing plus room and ancillary costs:

Type A 12 sq. m (Graphic size)	=	€ 1.750,-
Type B 8 sq. m (middle size)	=	€ 1.550,-
Type C 6 sq. m (small size)	=	€ 1.350,-
Type D shared booth (4 sqm per exhibitor)	=	€ 1.100,-
For exhibitors from abroad	=	€ 900,-
Type E Participation presence	=	€ 685,-

All prices plus 19 % VAT

8. Closing date for registrations:

Registration must arrive in writing on this form at the organizers by 30. June 2009. The registration is legally binding with the signature of the form and these conditions of participation.

9. Payment:

The participation costs are payable in two installments.

The first installment amounting to one third of the cost plus VAT is invoiced with the confirmation of registration of the organizer. Payment is due within 14 days after issue of the invoice.

The remaining sum is payable on 10. November 2009.

10. Confirmation of registration / reservation of place / cancellation:

The number of booths is limited. The organizer alone decides on participation. The contract on participation in the fair is concluded only with the written confirmation of the organizer after the registration period. Applicants have no legal claim to registration.

Wishes of the exhibitor as to location will be taken into account as far as possible, but the organizer reserves the right to make changes later if these are necessary. Without the consent of the organizer, exhibitors may not sublet a stand or parts of it to third parties or let them otherwise use the stand.

After an issue of the confirmation of participation (date of the confirmation), the exhibitor can within 14 days in writing to the organizer withdraw from participation in the fair. There is no scheduled right of notice or withdrawal beyond this.

In the case of cancellation after this date or in the case of non-participation the full payment obligation remains.

11. Liability:

The organizer is entitled to postpone, shorten, close early or completely cancel the fair in case of events which he has not deliberately or through gross negligence occasioned. The exhibitor has no right of compensation against the organizer in such cases. Should the fair be canceled, no rent need be paid and any amounts already paid will be refunded. Exhibitors will, however, have to pay fully for work already completed and services rendered.

12. Insurance of the exhibits:

The insurance of the exhibits is the responsibility of the exhibitors. The organizer accepts no liability for any loss and/or damage. Exhibitors will be liable to the organizers for any damage resulting from their participation in the fair, whether caused by themselves or their vicarious agents, staff or authorized representatives.

Exhibitors themselves are liable for any damage inflicted on third parties or the organizers on their stands or through their activities. The organizers recommend that exhibitors take out liability cover for participating at the exhibition.

13. Guarding:

The organizer will arrange for the exhibition rooms to be guarded outside of the opening times of the fair. This does not release the exhibitor of his obligation to insure adequately his exhibits outside of the opening times of the fair. The exemption from liability of the organizer from damage to property is not affected by the guarding.

14. Exclusion:

If the participation conditions are not adhered to, the organizer reserves the right to immediate exclusion from the fair.

15. Final clauses:

Domiciliary right lies with the organizer on the entire fair premises throughout the periods allowed for the erection, holding and dismantling of the fair. Place of performance and venue is Kiel. The law of the Federal Republic of Germany applies. The German text is authoritative.
